THIS WILL BE A DIRECTED NET AND STATIONS ARE REQUESTED TO TRANSMIT **ONLY
TO NET CONTROL EXCEPT IN THE CASE OF EMERGENCY. THIS IS _____, MY
NAME IS _____ AND I WILL BE SERVING AS NET CONTROL OPERATOR
DURING THIS NET. IS THERE ANY EMERGENCY OR TIME VALUED TRAFFIC AT THIS
TIME?**

**I WILL NOW BEGIN TO ACCEPT CHECKINS FOR THE NET – PLEASE INDICATE WETHER
YOU ARE OPERATING BASE OR MOBILE AND IF YOU ARE AVAILABLE FOR GOING
MOBILE.**

**FOR THE SAFETY OF ALL PARTICIPATING DO NOT LEAVE THE NET WITHOUT
NOTIFYING NET CONTROL FIRST...PLEASE CHECKIN NOW:**

*Check with liaison to the NWS and for radar reports as necessary. Dispatch spotters to
their normal location or elsewhere as indicated by the track of the Storm system. Note
hail size and wind speeds, **(determine if measured or estimated)** Report to NWS via
NWS liaison station hail size 1/4in and above, rain in excess of 1inch per hour,
impassable flooded roads, downed trees or limbs, downed power lines etc...NWS wants
to know all these things.*

**If brought up by NWS and released by the NWS conclude proceedings like this:
**WE HAVE BEEN ADVISED TO STAND DOWN BY THE NATIONAL WEATHER
SERVICE AT THIS TIME. Continue below:***

***If not brought up by NWS conclude proceedings like this:*

**WE NOW SECURE THE NET THANKS TO ALL FOR THEIR COOPERATION AND
HELP. THIS COULD NOT HAVE BEEN DONE WITHOUT YOUR HELP AND
SUPPORT.ALL NET PARTICIPANTS SIGN CLEAR WITH NET CONTROL.**
